Innovative aspects:

Since the antiCovid measures did not allow us to organize any dissemination event in attendance, we have held a second online course addressed to teachers of Milan schools from elementary to high-school. The teachers who had already attended the first meeting on the Clilstore platform potentiality, have been preferably enrolled in the course. In order to make the best out of this experience, we have opened some "rooms" on Zoom to work in small groups. After a general introduction, the teachers have started to work in each stanza alternatively to get more familiar with the use of Multidict. Wordlink and the main functions to create a unit on Clilstore. The course has been officially acknowledged by the Minstry of Education and included in the national platform "SOFIA" for teachers' training. Both the trainees and the trainers have received an attendance certificate.
